The Board hopes everyone had some well-earned downtime over the festive season and wishes you all the best for 2023.

Updates to Guidelines for Significant Alterations

The Board has updated its guidelines for its classification of a Significant Alteration. If you are thinking of refurbishing/altering your registered premises, please ensure you look at the <u>Guidelines</u> to see if your plans constitute a Significant Alteration.

During our compliance audits, we have noted a number of premises plans differing from those held at the Board's Register. When our officers note a difference during an audit, an application for a significant alteration must be commenced. The applicant will be charged the relevant fee.

If you are unsure what you are planning constitutes a Significant Alteration, it is better to check with the Board officers. Asking permission rather than forgiveness is the better course of action.

Application Fee Structure Changes

The Board has updated its fee structure for the processing of Relocations, Changes to Ownership etc. The fees are unchanged but due to the increased workload involved, separate fees will apply for each type of application. For example, if you are applying for a Relocation along with a Change of ownership the fee will be \$2000. That is, \$1000 for each section. These fees will apply for any application commenced after the 1st January 2023. You may find the fee structure here.

Changes of Ownership Updated Requirements

The Board has updated its requirements for the processing of Changes to Ownership. For any application commenced after the 1st March 2023 (this means for the meeting of the Board on 19 April 2023, with the cut-off being 20 March 2023), the Board will require you to provide a <u>Premises</u> plan along with the application. If you are selling your business, it may be prudent to have an updated Premises plan, as per the Board's requirements (refer to <u>Guidelines for Plans of Registered Premises</u>), to ensure the timely sale. A Building plan is not needed for this application.

Board Meeting in January 2024

The Board will not be meeting to discuss any applications in January 2024. If your premises application is time sensitive, please ensure your paperwork is at our offices in time to be considered at the December 2023 meeting.
