The Board advises pharmacists with overall responsibility (**Responsible Pharmacists**) the online Application Form will soon be delivered to your Inboxes. We are also pleased to advise the fee is the same as last year.

It has come to our attention that last year some Responsible Pharmacists made their statutory declaration without ensuring the premises was compliant with the access to reference documents and equipment on premises requirements of Schedule 1 of the Pharmacy Regulations 2010 (the Minimum Standards). Therefore, we strongly recommend you check the premises has access to current print or online editions of all required reference documents, and is equipped with all items of equipment, before you complete your application.

Because the online form must be completed in one session, we also strongly recommend you first familiarise yourself with the <u>SAMPLE Application Form</u> so you are aware of all the renewal requirements before you complete your application. The <u>SAMPLE Covering Email</u> is also available for easy reference.

Making use of this opportunity will ensure your statutory declaration is made knowing all the statements are true and correct. Failure to do so may result in the Board determining your application included false and misleading information and imposing a fine.

Remember, to open on 1 July 2022, processing of your application must be complete, and payment of the fee must be settled, by the deadline date of 30 June 2022.
